

## Vendor Conditions & Guidelines for Participating in the Perry Hall 2019 Apple Festival—Sat & Sun Sept 21 & 22, 2019

The following are additional rules and restrictions to which you are subject as a vendor at this event.

- Fair hours are 10am–5pm on the grounds of Chapel Hills Farm & Nursery 4350 Chapel Road, Perry Hall, MD 21128
- Booth area is 10x10 and is space only, **on grass**. Tents, tables and chairs and electricity are not provided. **NO generators.**
- Vendors will be allowed entrance into the fair area beginning at 7:00am on the day of the event. Set-up must be completed by 9:30am. Vendors will be directed to their spaces by event staff, and are expected to unload their equipment and materials and **IMMEDIATELY** remove their vehicle from the area. An event staff member will be on hand to supervise your space while you park your vehicle.
- Vendors may not move their assigned locations.
- Event staff reserves the right to require vendors to cease sales of any product or material deemed destructive or dangerous on the day of the event.
- Material cannot be distributed outside of your assigned booth space. Distribution of food or drink items, other than by food vendors is not allowed.
- Vendors may not begin breakdown before 5pm. You are responsible for the clean-up of your space. Vendors who leave debris or trash behind will be billed \$100.00 and will be prohibited from future participation.
- Vendors are responsible for collecting any applicable Maryland State Sales Tax.
- Violations of any of these rules will result in revocation of vendor privileges and you will be asked to leave.
- **Raindate info:** The Raindate is scheduled for the following weekend—9/28 and 9/29. **Cancellations:** Please note that no refunds will be given in the event that you cancel or unable to attend the scheduled date or raindate (if applicable). Refunds will only be given if the festival is not held at all (partial refunds will not be given if the festival is only held on one day).

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

Vendor agrees to release, indemnify and hold harmless Chapel Hills Nursery and Farm (“Chapel Hills”), Perry Hall Improvement Association, Incorporated (“PHIA”), and their respective officers, directors, employees, agents, consultants, affiliates and volunteers from and against any and all injuries, claims, damages, or causes of action, of any kind or nature whatsoever, including without limitation claims for damage to any real or personal property, personal injury or death, and including all costs and attorney’s fees, arising out of Vendor’s participation in the Festival or any related activities.

3. This Agreement shall be binding on, and shall inure to the benefit of the Vendor, Chapel Hills, PHIA, and their respective heirs, successors and assigns.

4. This Agreement shall be governed by the laws of the State of Maryland notwithstanding any conflict of law rules.

5. By signing below, I hereby certify that I am at least 18 years of age and authorized to execute this agreement, and I acknowledge that I understand, accept and agree to be bound by the terms and conditions set forth in this agreement.
